



## Fees

Fees are to be paid in advance at the beginning of each month by standing order, details of which will be provided on registration. These payments are required regardless of child's attendance due to illness or holiday. In the case of an absence, you will also not be able to "make -up" this lost day at a later date. We do accept childcare vouchers which will need to be set up through your employer giving them the registration number EY450792. Please note any late fees will incur an additional daily charge of 10%. These fees are effective from September 2026.

## Cost

The monthly cost will depend on your child's age, with specific day rates indicated in parentheses.

## Funding

Children aged 3 and 4 are entitled to free places from the beginning of the term following their third birthday, as set up by the government. This provides 15 hours of free childcare a week over a 38-week period (the academic school year). Since we are open all year round, the hours have been adjusted to cover the cost of a full year, resulting in 10.96 free hours a week for the entire year.

You will be able to claim this funding the term after your child's third birthday.

| Date of 3rd Birthday     | Term funding starts from |

You do not have to do anything to apply for this funding but you will need to fill in our funding declaration form, which will be sent to you by the nursery.

## Further Funding for Eligible Working Parents

From September 2025 we've been offering 30 hour funded places to children from 9 months of age onwards to eligible working parents who do 3 or more days a week. This funding is dependent on your working and financial status. It is up to the parents to contact the HMRC to find out if they are eligible for this funding <https://www.childcarechoices.gov.uk/>

If parents are eligible they will be given a unique eligibility code. This code, along with our funding declaration form, is required before a funded space can be confirmed. You must reconfirm this code every three months to maintain eligibility. Failure to do so will result in full fees being charged.

## Additional Costs

The funding does not include consumables, meals, trips, events or additional classes. The funding covers the first 15 or 30 hours of your child's week regardless of attendance days, for the 38 week funded year. Below is the daily extras that have already been included into the monthly sum above. To opt out of the extras please contact management.
